- Medic clinic update
 - 1102 S. Park; Free Saturday Clinic; flyer to listserv will be shared; appts 8am 12pm, 2 patients per hour; plenty of openings currently; they can prescribe medications that are not on the controlled substances list.
 - Medic clinic is not a continuity clinic. They function more like an urgent care; however, there is capacity right now for folks to get connected to a primary care home through Access when they are seen at the Medic Clinic. The cost for this is covered by UW Health; funding will continue for next year.

- Reinforced in the chat: "Medic is for acute care/urgent care if they cannot get care in regular clinic. If people already have a primary care they should go to their primary care. If not urgent they should then call ACHC including Wingra to try to establish primary care.
- Access also has openings right now for uninsured patients who do not have a medical home.

- **COVID updates** Still working with Access to give vaccine education. Yolanda still recruiting from home 608-441-9918 if folks need vaccine, booster, or they have questions. Calls can be received between 7am 8pm, also Saturday and Sunday. We will see more messaging from LHC that vaccines and masks are still important.
 - O Data shared:
 - o At least 1 vaccine: Latinx in Dane County at 80% non-Latinx 76.9%
 - o 2 doses of vaccine: 73% for both Latinx and non-Latinx populations
 - o For 18 and over about 91% latinx have received vaccine
 - Total population that has received booster is where we are seeing the need for work: Latinx pop 29% non-Latinx 45%
 - Message: focus work with youth, kids, and folks needing boosters. Also continue to advocate mask use to help those who wish to wear one feel safe.
 - 4 pre-med students will work with 35 businesses to provide education about masking and posters on vaccines and boosters for them and their clients; adding 30 additional businesses (grocery stores and restaurants)

Events

- Considering bringing events back, however, we will start very cautiously with reduced numbers.
- Mental Health Summit proposing 50 people (instead of 150 as in the past); We will require
 masks, hand washing, social distancing; likely half day instead of full day to test how things go.
 Tentative date Sat, 5/21, 9am 2pm; Will require proof of vaccination (and can facilitate
 helping them to get it prior to the event)
- May need volunteers and organizations' help with giveaways for treat bags

 medical school.

Presentations:

Access presentation - Dan Martin, Chief Clinical Services Officer

- Pandemic response highlighted Given close to 15,000 doses of vaccines to close to 9,000 people;
 Done over 30 after-hours (evening/weekend) clinics; maintained the ability to give vaccines at the time of other clinic appointments; have been able to keep disparities in this area in check; considering education and outreach efforts to patients once the vaccine opens to small children.
- Telehealth 20 40% of clinical visits and 50 60% of behavioral health visits; predicts telehealth will continue to be a core part of the model post-pandemic
- Expanding care for people in the community without insurance with donations and pandemic relief funding since June of last year, seen 320 patients seen without insurance/connections (7x the people seen the previous year); and hopes to expand this to dental (down 4 dentist FTEs right now)
- Celebrate Smiles is back this year. Only providing preventive care at this time. 2100 kids seen in 22 schools since Sept. 2021. Kids needing restorative care referred back to clinic, but far fewer make it back to the clinic.
- Planning to purchase a mobile unit in 2023 that will allow the full scope of pre-pandemic services.
- Staffing frontline is a particular challenge; recruiting in traditional way, but also bringing back a
 program to train dental assistants in-house (as has been done in the past); also looking at how to do
 that for medical assistants. If we know folks who may be interested or have questions about

- Latinx Patient Advisory Council started pre-COVID. Gather every 2 months to get group feedback and input in order to be more culturally appropriate in new programs.

PHMDC presentation: Sexual and Reproductive Services at PHMDC – Lourdes Shanjani And Liliana Lema

- Local Health Dept with significant growth in the last 2 years 160 staff members serving more than 60 cites/towns across Dane County
- Presentation attached general overview of PHMDC shared along with detailed overview of sexual and reproductive services;
